5. Points from Combined Tests that are applied toward Year-End Awards **MAY NOT** exceed the total number of points from Horse Trials, CIC'S, CCI'S or any type of long format 3-Day Event. For example, if you have 6 points from Combined Tests and 4 from Horse Trials, your total is only 8 points. If you have 10 from Combined Tests and none from Horse Trials, you have no points.

6. At the present time we are not tracking points for Eventing Equitation Tests, Young Event Horse Tests, Future Event Horse, etc. As the sport of eventing continues to evolve and there are new types of tests with combinations of two or three phases including dressage, xc or show jumping in a competition, we will endeavor to fit them in and expand our definitions above.

Eventing Team Competitions

CDCTA may send teams to Team Competitions hosted by local Horse Trials such as Virginia Horse Trials and Adult Team Championships. Our teams are selected through applications* sent in during the summer, and point standings for Year-End Awards. CDCTA pays the entry fee for team members, however, riders are responsible for all other expenses. The exact dates will be published in the web site. If you are interested in applying for a team—the forms can be found on the web site at <u>www.cdcta.com</u>.

Dressage & Eventing Scholarships

These grants are intended to further the education of a single outstanding senior or junior dressage rider who is a current member of CDCTA. Riding and competitive experience along with volunteer activities will be taken into account when determining the recipient of the scholarship. The winner is expected to provide a written statement to the newsletter at the end of the year describing his/her activities and explaining how they have benefited as a grant recipient.
